The deadlines applicable to local authorities are as follows:

- Approve Draft Accounts 31 May 2024
- Public Inspection Period to include the first 10 working days of June (see #)
- Publish Final Audited Accounts 30 September 2024

Please note that although the public inspection period is required to include the first 10 working days in June, as the statement of accounts were not authorised for issue by the Chief Finance Officer until 15th January 2025, this was not possible. For that reason, the public inspection period has therefore been amended to six weeks from Thursday 16th January 2025.

The accounts and other documents will be available for inspection at Cumbria Fire and Rescue Service Headquarters, Carleton Avenue, Penrith, CA10 2FA by prior arrangement. Please telephone 01768 812612 to make an appointment. The accounts will also be available on the Cumbria Fire and Rescue Service website: www.cumbriafire.gov.uk

During this period, a local government elector for any area to which the accounts relate, or their representative, may question the auditor about the accounts, or make an objection to the accounts as set out in sections 26 and 27 of the Local Audit and Accountability Act 2014. Any objection, and the grounds on which it is made, must be sent to the auditor in writing, with a copy to the relevant officer of the Fire Authority. Any objection must state the grounds on which the objection is being made and particulars of:

- any item of account which is alleged to be contrary to law; and
- any matter in respect of which it is proposed that the auditor could make a public interest report under section 24 of, and paragraph 1 of schedule 7 to, the Local Audit and Accountability Act 2014.
